1.0 Joining as members:

- 1.1 Membership is open to all businesses/firms engaged in retailing, wholesaling or manufacturing of jewellery*.
 - * "Jewellery" refers to genuine precious gemstones, semi-precious gemstones; and precious metals such as gold, silver and platinum ornaments, but excluding stainless steel and titanium.
- 1.2 At least 95% of the jewellery inventory in the jewellery retail front must be genuine gemstones, gold (at least 14K or 58.5% pure gold content) and platinum (at least 800 in purity)
- 1.3 The Association is not required to give any reason for rejected applications.

Please attach photocopies of the following items upon submission of the application form.

- 1. Accounting and Corporate Regulatory Authority (ACRA) Business Profile (Company) including Director information;
- 2. Certificate of Registration GST, if any;
- 3. Description of the Company.

期限与条约

1.0 入会手续:

- 1.1 会员开放给所有经营零售、批发、制造珠宝首饰之商业机构/商号或买卖金银之商行皆有资格申请为本会会员*。
 - * "珠宝首饰"的定义为天然贵重宝石,半宝石;贵重金属例如黄金、银和铂首饰,不包括不锈钢和钛。
- 1.2 零售店面所出售的首饰必须有至少95%的存货是天然贵重宝石,半宝石及贵重金属镶造的制成品(即至少14K或足金含量为58.5%或以上)或铂金(至少800成分)。
- 1.3 申请者被接受与否,本会无需解释任何理由。
