The Guidance Paper summarised the key findings, elaborated on the sound practices observed and detailed MinLaw's supervisory expectations of effective AML/CFT controls in the PSPM sector.

All registered dealers are ultimately responsible and accountable for AML/CFT compliance. It is important to stay up-to-date with new, emerging ML/TF risks and put in place processes, measures / controls to mitigate these risks for your organisation.
