# [COVID-19] UPDATED SAFE MANAGEMENT MEASURES FOR THE RETAIL SECTOR

In order to slow down community transmission, the Government has introduced a <u>tightening</u> of <u>community safe management measures</u>. A summary may be found <u>here</u>.

<u>Stabilisation Phase (27 September through 24 October 2021)</u> In particular, enterprises should take note of the following :

- Permissible group sizes for social gatherings will be reduced to a **maximum of 2 persons**
- Work-from-home will now be the default. The 10-day snap work-from-home regime will be suspended.
  - o Employees, contractors and vendors who are unable to work from home are strongly encouraged to <u>self-test weekly</u> via an Antigen Rapid Test (ART)
  - o Those who are able to work from home but need to return to the workplace for adhoc reasons may <u>only do so after testing negative via ART</u>
- The Government will enhance the <u>Jobs Support Scheme</u> support to 25% for the period of 27 September 2021 to 24 October 2021 for sectors significantly affected by the tightened measures. Please access <u>here</u> for details.
- As announced by the Ministry of Finance on 24 September 2021, there will be a third Rental Support Scheme (RSS) payout to qualifying tenants and owner-occupiers in private commercial properties. IRAS will provide details of the third RSS payout in early October 2021.

#### 零售业更新安全管理措施

为了减缓冠病在社群传播,政府推出<u>收紧安全管理措施</u>。您可以在<u>此处</u>找到相关的指导摘要。

稳定疫情阶段(2021年9月27日至10月24日)

企业应注意以下几点:

- 社交聚会人数将从5人减少至2人
- **居家办公再成为常态模式**,十天临时居家办公(Snap work-from-home)即日停止
  无法在家工作的员工、承包商和供应商,卫生部强烈建议他们每周进行抗原 快速检测(ART)自我检测,以确保工作场所的安全。
  - 那些能够在家工作但基于特殊原因,临时需要返回职场的人,也可以在完成 ART 自我检测呈阴性后才能回公司办公。
- 政府将从 2021 年 9 月 27 日至 2021 年 10 月 24 日期间,因收紧安全管理措施而 严重受影响的业者,通过雇佣补贴计划提供 25%的薪金补贴。请浏览<u>此处</u>了解 详情。
- 财政部于 2021 年 9 月 24 日宣布,将给予符合条件的租户和自用业主发放租金援助租金计划(RSS)的第三笔援助金。新加坡税务局(IRAS)将在 2021 年 10 月上旬宣布第三笔 RSS 援助金的详细信息。

# Exercise Vigilance, Stay Safe Safe Management Measures -**Stabilisation Phase**

Safe Management Measures (SMMs) will be tightened to minimise the strain on our healthcare capacity. The following measures will take effect from 27 September 2021 - 24 October 2021.

## Workplace Updated

- Work from home is the default for employees who are able to work from home
- No cross-deployment of workers to multiple worksites.
- Stagger work and break hours.
- Social gatherings at the workplace are not allowed.
- Employees who are unable to work from home are strongly encouraged to self-test weekly via an Antigen Rapid Test (ART).
- Those who are able to work from home but need to return to the workplace on an ad-hoc basis may do so after testing negative via ART before working onsite
- The snap 10-day WFH regime will be suspended during this period.

*Companies do not need to apply for permission to work onsite.* 



## Social Gathering Updated

- Group sizes of up to <u>2 persons</u>.
- Up to 2 unique household visitors per day.
- 1 social gathering per day, whether to another household or in a public place.
- The cap on visitors does not apply to grandchildren being cared for by grandparents.



# **Dining-in**

### F&B establishments (Updated)

- Dine-in allowed with group sizes of up to **<u>2 persons</u>** if all are fully vaccinated.
- Unvaccinated individuals are allowed to dine-in only if they have a valid negative pre-event test (PET) result.
- Live performances, recorded music, and video/TV screenings are prohibited.

#### Hawker centres and coffeeshops

• Dine-in allowed with group sizes of up to **<u>2 persons</u>** regardless of vaccination status.



## **Congregational and other** worship services, cinemas, MICE, live performances and spectator sport events

• Up to 1,000 attendees if all are fully vaccinated; up to 50 attendees without PET.



## Marriage solemnisations and wedding receptions

- Marriage solemnisations: Up to 1,000 attendees if all are fully vaccinated; up to 50 50 attendees without PET.
- Wedding receptions: Up to 250 persons if all are fully vaccinated, with a group size of





## **Targeted Support Measures**

#### Jobs Support Scheme (JSS)

• Enhanced JSS support to 25% for affected sectors, including F&B, retail, cinemas, museums, art galleries, historical sites, family entertainment, tourism, gyms and fitness studios, and performing arts and arts education.

#### **Rental support**

- 2-week rental waiver for qualifying tenants on Government-owned commercial properties.
- 2-week rental relief cash payout under the Rental Support Scheme to gualifying tenant-occupiers and occupiers of privately-owned commercial properties.
- 2-week rental waiver for cooked food and market stallholders in centres managed by the National Environment Agency (NEA) or NEA-appointed operators.

#### COVID-19 Driver Relief Fund (CDRF) extension

• To support taxi and private hire car drivers, the CDRF payout at \$10 and \$5 per vehicle per day will be extended to October and November 2021 respectively.

## **Regular Self-Testing for All**

Firms with employees that work onsite and are not already subject to mandatory RRT can apply for 8 ART kits per onsite employee for weekly testing of their staff over a two-month period. Applications are opened until **13 October 2021**. More details can be found at www.go.gov.sg/time-limited-rrt-art.


