* “Jewellery” refers to genuine precious gemstones, semi-precious gemstones; and precious metals such as gold, silver and platinum ornaments, but excluding stainless steel and titanium.

1.2 At least 95% of the jewellery inventory in the jewellery retail front must be genuine gemstones, gold (at least 14K or 58.5% pure gold content) and platinum (at least 800 in purity)

1.3 The Association is not required to give any reason for rejected applications.

2. **Certificate of Registration - GST, if any;**
3. **Description of the Company.**

1.0 入会手续:

1.1 会员开放给所有经营零售、批发、制造珠宝首饰之商业机构/商号或买卖金银之商行皆有资格申请为本会会员*。
