## Terms & Conditions

### **Requirements:**

1. Membership is open to all businesses/firms engaged in retailing, wholesaling or manufacturing of jewellery\*; precious metal refineries and institutions offering jewellery training courses or gemological services.

*\*"Jewellery" refers to genuine precious gemstones, semi-precious gemstones; and precious metals such as gold, silver and platinum ornaments, but excluding stainless steel and titanium.*

- At least 90% of the jewellery inventory in the jewellery retail front must be genuine gemstones, gold (at least 14K or 58.5% pure gold content) and platinum (at least 800 in purity).
  - A minimum paid up capital of S\$250,000.
2. It is compulsory for all branches of a member-firm to be Branch Member of the Association (hereinafter referred to as "Branch Member").
  3. All members are to abide by the Association's Rules and Regulations, all resolutions passed at SJA meetings and fulfil all duties as a member thereof. All payments due are required to be paid within 7 days of the invoice date or otherwise specified.

*Note : No reason will be given for rejected applications.*

- i) **A copy of the Accounting and Corporate Regulatory Authority (ACRA) - Business Profile (Company) including Director information;**
- ii) **A copy of the Certificate of Registration - GST, if any;**
- iii) **A profile of the company (describing the business activity and information of the company)**

## 期限与条约

### **入会准则:**

1. 会员开放给所有经营零售、批发、制造珠宝首饰之商业机构/商号或买卖金银之商行皆有资格申请为本会会员\*。

*\* “珠宝首饰” 的定义为天然贵重宝石，半宝石；贵金属如黄金、银和铂首饰，不包括不锈钢和钛。*

- 零售店面所出售的首饰必须有至少95%的存货是天然贵重宝石，半宝石及贵金属镶嵌的制成品（即至少14K或足金含量为58.5%或以上）或铂金（至少800成分）。
  - 公司最低实收资本为S\$250,000。
2. 会员商号的所设分行必须成为本会“分行会员”。
  3. 所有会员均应遵守本会章程和本会会议通过的各项决议，履行会员应尽的义务。所有应付款项均须在发票日期的7天内支付或指定的日期。
